Government Required Documents

Families wishing to apply at TEDA International School must meet one of the five categories listed below. Please choose the appropriate category and submit all relevant documentation to the admissions office.

Categories:

A. Student and parents have foreign passports.

B. Student has a foreign passport. One or both parents are PRC passport holders.

c. Student is a PRC passport holder with a foreign country permanent residence permit. At least one of the parents has a foreign permanent residence permit, a record of permanent residence in that country for at least two years.

D. Students from Taiwan, Hong Kong SAR and Macau SAR are eligible for admission.
